

Software Notice 09-C - Amended

Important: This notice has been amended to include a required version of the Sage Master Builder API. If you have already installed Software Notice 09-C, you only need to install the updated API (SMBAPI1340.exe).

Important Update Information

- This update can be installed over Version 13 only. **If you are on Version 12 or prior, you will need to first upgrade to Version 13 from the installation CD and then install the update.** If you are unsure which Sage Master Builder version you have installed, follow these instructions:
 1. Launch Sage Master Builder, and log in to your company.
 2. Click **Help > About Sage Master Builder**. The second line displays the CD version number.
- Software changes in this update are cumulative. If you determine from reading the [Release Notes](#) that you were required to install an update released previously but did not, you can install this update to meet that requirement.

Solution

Download and install the Software Update 09-C to update Sage Master Builder for changes to Federal payroll tax tables, changes to the Federal form 941, Utah Workers' Compensation, updates to the documentation, and/or an updated API.

Download and Installation Instructions

To download the tax update and/or API update:

1. Close Sage Master Builder before downloading the Software Update 09-C.
2. Click each link below, or enter it into your Internet browser address line. If you see a security alert, click **[Allow]**.

3. When the **File Download** window opens, click **[Save]**.
4. In the **Save As** window, select the drive and folder where you want to save the tax update file and/or API update then click **[Save]**. We recommend that you write down the location of the saved file so that it is easy to locate for the installation.
 - a. For a multi-user/network configuration, save the file to a shared directory on a computer on your network.
 - b. For a stand-alone configuration, save the file to a directory on your workstation.

Tip: The file will start downloading. Downloading the file may take a few minutes.

To install the update:

Tip: It is important to install the update to all locations on your network. This will make sure that all locations contain the latest updates to the Federal payroll tax tables, 941 form, Utah Workers' Compensation, and updated documentation. To ensure that the update is installed to all necessary locations, first install the update directly to the server, and then install it to the local drives of all other workstations.

1. Close all open programs before installing the update.
2. Browse to the directory where you saved **SMB1340.exe** and **SMBAPI1340.exe**.
Important: Install **SMB1340.exe** first. Both files will need to be installed.
3. Double-click the downloaded **SMB1340.exe** file to begin the installation.

Note: For those running the Windows XP operating system. If you get a message advising you that the program publisher cannot be identified, click **[Run]**.

Note: For those running the Windows Vista operating system. If you get a message advising you that an unidentified program wants to access your computer, click **[Allow]**.

4. Click **[Next]**.
5. Select the drive letter where Sage Master Builder is currently installed. The update installation process will verify that it is updating the correct version of Sage Master Builder.
6. Click **[Next]**.

7. Review the update modifications, and then click **[Next]**. The program files are installed.
8. Select **Yes, I want to restart my computer now** if you are prompted, then click **[Finish]**. If the option to restart your computer is not presented, click **[Finish]**.
9. Repeat steps 1-8 to update all other computers running Sage Master Builder and the computer where all your data is located.

Note: On PCs running the Vista operating system, if you receive a Windows Program Compatibility Assistant message after completing the installation advising you that the program didn't install correctly, click the option, **This program installed correctly**.

Software Update 09-C

Payroll tax version 2009.1.0.9 (02/25/2009)

- **Federal payroll tax**
- **Utah Workers' Compensation** - Based on changes to Utah workers' compensation rules for all policies written or renewed after June 1, 2008, overtime pay will be excluded from payroll calculations. To accommodate the changes, a new menu option has been added to the **5-3-2 Workers' Compensation** window: **Options > Calculation for Utah excludes extra pay for overtime**. For more details see the Help topic, Utah Workers' Compensation.
- **Federal form 941** - The Federal form 941 has been changed for 2009. The **5-4-1 941 Federal Quarterly Report** window has been updated to correspond to the changes in the Federal form. In addition, the Help topic, "Preparing the Federal Quarterly 941 Report," has also been updated.
 - **Line 12-a** - COBRA premium assistance payments. The form instructions note that employers should only report the COBRA premium assistance payments that they made on behalf of workers. The amount should be 65% of eligible workers' total COBRA premium payments.
 - **Line 12-b** - Number of individuals provided COBRA premium assistance reported on line 12a.
 - **Section 7, Tax Adjustments** - The adjustments in section 7 have changed.

- **Certified Payroll Reports**
 - **5-1-6-21** - Option to print with masked social security numbers (only the last 4 digits are visible and can be used as an identifier) and an option to exclude employee address information.
 - **5-1-6-31** - Option to print with masked social security numbers (only the last 4 digits are visible and can be used as an identifier) and an option to exclude employee address information.
 - **5-1-6-51** - Option to print with masked social security numbers (only the last 4 digits are visible and can be used as an identifier).

 - No changes to reporting or calculations.
 - Slight adjustments to fields on the form so that the information prints in the correct position.
